The Institute has admitted **Ten (10)** candidates as per the list submitted, ie **Ten (10) management** quota



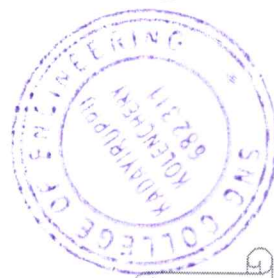

2. The ASC through communication dated 02.11.2020 has directed the Principals of the MCA Colleges to submit the scanned copies of the list and supporting documents of admitted MCA candidates for the academic year 2020-21 before the ASC for approval.

3. Accordingly, the MCA College through communication dated 29.12.2020 has submitted the list and supporting documents of admitted candidates for MCA Course.
4. The MCA College has submitted the affiliation order received from the competent authorities for conducting the above course. The ASC scrutinised the affiliation order and found that the MCA College is having an intake strength of 90 MCA Seats for the academic year 2020-21.
5. In the present Pandemic Situation, the Government has issued G.O.(Rt)No.1364/2020/HEDN dated 02.11.2020, prescribing certain guidelines for admission to MCA Course 2020-21, for filling the vacant/lapsed Seats for the admission to MCA course for the academic year 2020-21.
6. On verifying the records it is found that the MCA College has admitted 43 candidates in MCA Course for the academic year 2020-21. Among the 43 candidates admitted, 27 candidates are allotted by the LBS under Merit quota, 8 candidates are under Management quota and the remaining 8 candidates is under Merit Lapsed Seats (As per G.O.(Rt)No.1364/2020/HEDN dated 02.11.2020).
7. The ASC scrutinised the list and other supporting documents of 8 candidates under Management quota and 8 candidates under Merit Lapsed seats and found that the documents of the 16 candidates are acceptable and they are eligible for admission to MCA Course. Therefore, the admissions of the 16 candidates are hereby approved, as per the lists shown below.

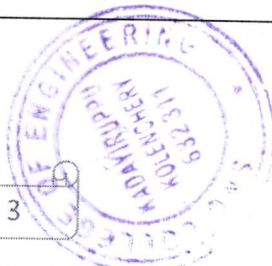

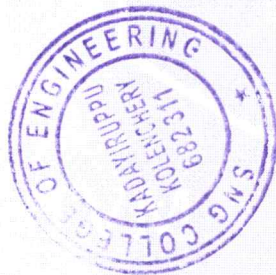
