The hostel operations shall not be interrupted during the repair activities at the roof and inside the premises. Working time shall be limited to morning 0800 hours to evening 1800 hours. The power supply and water connection required shall be obtained through electrical department of SNGCE. The work permit shall be duly signed off by both parties and duration shall be limited to 1 week maximum and extend upon requirement.

Workers engaged shall wear either pant and shirt or coverall whichever is feasible. Lunky/dhothy not allowed in the hostel premises. Safety Helmet, shoes and safety harness suggested for the workers working above 2 meter height from floor. Workers shall be insured and protected by minimum wage rules of the government. If any accident or injury at site shall be sole responsibility of the contractor. Gate entry /exit procedures must be followed at the start and end of the work on each day.

Waste disposal : All removed items to be stored in a designated place instructed by the SNGCE supervision. Fire extinguishers, sand buckets, water storage etc to be kept at site for the fire fighting as taken care by the contractor. During the execution of the work, each area must be barricaded underneath to prevent accidental entry of tenants. Area must be covered with plastic sheets or sufficient medium to restrict the entry of any one of the tenant.

Contractor to make arrangements to cover the areas over the roof with sufficient sheets to prevent water fall to the underneath in case rain started due weather change . In view of the uncertainty of change of weather , SNGCE suggested to start each section one by one to avoid inadvertent situations.

Contractor to furnish a project chart to specify the start date and end date of each section of the roof and all specified areas to be completed within 15 days time. Sufficient workers to be deployed to achieve the target in view of the rain in April / May months and monsoon.

Note : The area measured may slightly change . Contractor to measure each section at site and quotation shall be submitted for the actual measured area considering the overlapping of sheets and the cutting waste at corners.

b. Payment Terms

First Payment: - 10% of the contract value shall be paid to the contractor upon completion of the following works within one week time .

- a. Removal of existing polycarbonate sheet and shifting to designated location
- b. Welding of structure cracks if any, adding "purling" extra for the roof as decided by SNGCE supervision.
- c. Rust removal and cleaning of structures
- d. Painting of structures with one coat of Epoxy Zinc chromate primer and 1 coat of epoxy exterior paint.
- e. SNGCE supervision shall issue completion certificate of each activity noted above for the payment.
